PLANS IN SCOPE

Aspirus Health Plan

PURPOSE:

The intent of this policy is to provide coverage guidelines for specialty medical injectable drugs where a current policy does not exist.

Please refer to the member’s benefit document for specific information. To the extent there is any inconsistency between this policy and the terms of the member’s benefit plan or certificate of coverage, the terms of the member’s benefit plan document will govern.

COVERAGE INDICATIONS:

This policy provides parameters for coverage of medically injectable medications.

For consideration of coverage, all the following must apply:

1. The medication is ordered by a licensed provider
2. A medication specific policy is not available
3. All step therapy options have been applied
4. The medication must be provider administered or administration of the specialty drug must be supervised by a provider
5. The medication is approved by the FDA
6. The medication requested aligns with all FDA label indications for use
7. The requested medication dosing and frequency aligns with the FDA label recommended dosing and frequency

Exclusions

The following services are excluded from this policy:

- Medications that can be self-administered
- Medications that are considered investigational
- Off label medication use
- Unproven medication indications

Medical Records Documentation

Benefit coverage is determined by review of member specific benefit plan information and all applicable laws. Medical records documentation may be required to assess if the member meets criteria; however, provision of records does not guarantee coverage.
