



The Summary of Benefits and Coverage (SBC) document will help you choose a health [plan](#). What is the overall deductible?	No deductible Out-of-network provider /services: \$5,000 individual/\$10,000 family	See the upcoming pages for your costs for services this plan covers.
Are there services covered before you meet your deductible?	No	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	No	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan?	Durable Medical Equipment (in-network only): You pay 20% up to \$500 per individual Prescription drug : \$1,325 Individual \$2,650 Family	If you have other family members in this plan , no one family member will contribute more than the individual amounts to the overall family out-of-pocket limit . The out-of-pocket limit is the most you could pay during a coverage period (usually one year) for your share of the cost of covered services. This limit helps you plan for health care expenses. The federal maximum out-of-pocket is \$12,000 individual/\$24,000 family. This applies to all essential health benefits, including some services not included in the out-of-pocket limit . (i.e. certain level 3 & 4 prescription drugs and adult hearing aids covered under this plan).
What is not included in the out-of-pocket limit?	Copayments for Level 3 and Level 4 non-preferred specialty drugs . Coinsurance for adult hearing aids, premiums and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .

Will you pay less if you use a network provider?	Yes. See https://p1.aspirushealthplan.com/ETF/find-a-doctor.aspx or call 866.631.8583 for a list of network providers .	This plan uses a provider network . You will pay less if you use a provider in the plan's network . You will pay the most if you use an out-of-network provider , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing). Be aware, your network provider might use an out-of-network provider for some services (such as lab work). Check with your provider before you get services
Do you need a referral to see a specialist?	No	You can see the specialist you choose without a referral . However, it is recommended you get a referral to an orthopedist or neurosurgeon for low back pain
