Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. <b>Are there services covered before you meet your deductible?</b>	Yes. <u>Preventive care</u> services, office visits and prescription drugs, other than specialty drugs, purchased from a pharmacy are covered before you meet your <u>deductible</u> .
